

NOTICE OF NON-JUDICIAL FORECLOSURE SALE

WHEREAS, That certain Deed of Trust (the "Deed of Trust"), dated January 26, 2014 from Danielle K. Chuss ("Borrower"), as Grantor to Ryan Coggin, Trustee, filed for record in Real Property Records of Jones County, Texas on January 31, 2014 as Instrument Number 140295, in Vol. 386, pages 874 - 877, more particularly described therein, which serves as security for a \$36,900.00 promissory note described therein (the "Note") executed by Borrower and payable to the order of HB EQUITY, LLC and subsequently assigned to Homestead Opportunity Fund, LP on February 4, 2014 by Assignment of Mortgage, filed for record in Real Property Records of Jones County, Texas on February 7, 2014 as Instrument Number 140367 in Volume 387, Pages 186 & 187.
