

**JONES COUNTY COMMISSIONERS COURT  
REGULAR MEETING  
MARCH 13, 2023 - 9:00 AM**

The Commissioner's Court of Jones County, Texas, met this day in regular session with the following members present: Dale Spurgin, County Judge, presiding; Roy Spalding, Commissioner Precinct 1; Lonnie Vivian, Commissioner Precinct 2; Ross Davis, Commissioner Precinct 3; Joel Spraberry, Commissioner Precinct 4; and LeeAnn Jennings, Jones County Clerk.

**1. APPROVE MINUTES OF THE LAST REGULAR MEETING.**

Commissioner Spalding entered a motion to approve the minutes from the February 27, 2023 as presented. Commissioner Davis seconded the motion with all other Commissioners voting aye.

**2. DISCUSS AND TAKE ACTION ON APPROVING ALL TRUST PROPERTY BIDS AS ONE ACTION ITEM, AGENDA ITEMS 3-4.** Commissioner Davis entered a motion to approve agenda items three and four as one action item. Commissioner Vivian seconded the motion with all other Commissioners voting aye.

**3. DISCUSS AND TAKE ACTION ON A BID SUBMITTED BY CAMILO MENDEZ GOMEZ FOR THE PURCHASE OF (R13256), BEING THE NORTH FIFTY FEET (N 50') OF LOT NO. EIGHT (8), BLOCK NO. ONE (1), TENNIE MOORE ADDITION, CITY OF HAMLIN, JONES COUNTY, TEXAS; BEING THAT PROPERTY MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS IN EXHIBIT "A" ATTACHED TO A SPECIAL WARRANTY DEED RECORDED IN VOLUME 267, PAGE 594 OF THE OFFICIAL RECORDS OF JONES COUNTY, TEXAS. **18. AMEND BUDGET AND APPROVE LINE ITEM TRANSFERS.**




**19. PAY BILLS.**


Commissioner Spalding entered a motion to pay the bills as presented by the Auditor. Commissioner Vivian seconded the motion with all other Commissioners voting aye.




Commissioner Vivian entered a motion to adjourn. Commissioner Spalding seconded the motion with all other Commissioners voting aye.


