

**JONES COUNTY COMMISSIONERS COURT  
REGULAR MEETING  
FEBRUARY 12, 2024 - 9:00 AM**

The Commissioner's Court of Jones County, Texas, met this day in regular session with the following members present: Dale Spurgin, County Judge, presiding; Roy Spalding, Commissioner Precinct 1; Lonnie Vivian, Commissioner Precinct 2; Ross Davis, Commissioner Precinct 3; Joel Spraberry, Commissioner Precinct 4; and LeeAnn Jennings, Jones County Clerk.

**1. APPROVE MINUTES OF THE LAST REGULAR MEETING.**

Commissioner Spalding entered a motion to approve the minutes from the January 22, 2024 regular meeting as presented. Commissioner Vivian seconded the motion with all other Commissioners voting aye.

**2. DISCUSS AND TAKE ACTION ON AN APPLICATION BY PETITION TO CLOSE CR 441 AND A PORTION OF CR 443.** No action was taken by the Commissioners Court. See Exhibit A.

**3. DISCUSS AND TAKE ACTION ON A BID SUBMITTED BY JAMES AND TIFFANY ZELLER FOR THE PURCHASE OF (R15363), A0902 174 BBB&C TRACT A, ACRES 2.754. THE BID AMOUNT IS \$8,000.00. COURT COSTS ARE \$889.00.** Commissioner Davis entered a motion to approve a bid in the amount of \$8,000 submitted by James and Tiffany Zeller for the purchase of R15363. Commissioner Spalding seconded the motion with all other Commissioners voting aye. See Exhibit B.

Commissioner Vivian entered a motion to approve a bid in the amount of \$5500 submitted by Roy Spalding for the purchase of a 580 Case Backhoe from Precinct 2. Commissioner Spraberry seconded the motion with Commissioner Davis and Judge Spurgin voting aye. Commissioners Spalding abstained. See Exhibit C.

Commissioner Vivian entered a motion to approve a bid in the amount of \$2000 submitted by Roy Spalding for the purchase of a dump truck from Precinct 2. Commissioner Spraberry seconded the motion with Commissioner Davis and Judge Spurgin voting aye. Commissioner Spalding abstained. See Exhibit C.

Commissioner Spalding entered a motion to approve a bid in the amount of \$5 for a Bostitch Hole Punch, \$1 for hanging file folders, \$5 for HP White Gray Office Jet Pro 9025, \$2 for computer tray, \$5 for gray chair with no handles, \$5 two drawer brown desk and \$1 for three black paper trays submitted by Michelle Moreno. Commissioner Vivian seconded the motion with all other Commissioners voting aye. See Exhibit C.

Commissioner Vivian entered a motion to approve a bid in the amount of \$50,516.21 submitted by Lawrence Hall Ford for the purchase of 2023 Ford F150 4x4 for the Constable. Commissioner Spalding seconded the motion with all other Commissioners voting aye. See Exhibit D.

Commissioner Spalding entered a motion to approve the advertisement for the purchase of a vehicle for the Sheriff's Office. Commissioner Vivian seconded the motion with all other Commissioners voting aye. See Exhibit D.


**ADJOURN**
