REGULAR MEETING
NOVEMBER 23, 2020 - 9:00 AM**

The Commissioner's Court of Jones County, Texas, met this day in regular session with the following members present: Dale Spurgin, County Judge, presiding; James Clawson, Commissioner Precinct 1; Lonnie Vivian, Commissioner Precinct 2; Ross Davis, Commissioner Precinct 3 (by phone); Joel Spraberry, Commissioner Precinct 4; and LeeAnn Jennings, Jones County Clerk.




15. PAY BILLS.


Commissioner Clawson entered a motion to pay the bills as presented. Commissioner Vivian seconded the motion with all other Commissioners voting aye.

Commissioner Clawson entered a motion to adjourn. Commissioner Vivian seconded the motion with all other Commissioners voting aye.



County Judge
