CALLED MEETING
MARCH 30, 2020 - 9:00 AM**


The Commissioner's Court of Jones County, Texas, met this day in regular session with the following members present: Dale Spurgin, County Judge, presiding; James Clawson, Commissioner Precinct 1; Lonnie Vivian, Commissioner Precinct 2; Ross Davis, Commissioner Precinct 3; Joel Spraberry, Commissioner Precinct 4; and LeeAnn Jennings, County Clerk.

- 1. DISCUSS AND TAKE ACTION ON REAPPOINTMENT OF CHAD WHITE AS PUBLIC HEALTH AUTHORITY.** Commissioner Davis entered a motion to reappoint Chad White as the public health authority. Commissioner Spraberry seconded the motion with all other Commissioners voting aye. See Exhibit A.
- 2. DISCUSS AND TAKE ACTION ON APPROVING ALL TRUST PROPERTY BIDS AS ONE ACTION ITEM, AGENDA ITEMS 3-9.** Commissioner Davis entered a motion to approve agenda items three through nine all in one action item. Commissioner Vivian seconded the motion with all other Commissioners voting aye.


Commissioner Clawson entered a motion to adjourn. Commissioner Vivian seconded the motion with all other Commissioners voting aye.




County Judge



Commissioner Precinct 2




Commissioner Precinct 4
