

NOTICE OF NON-JUDICIAL FORECLOSURE SALE

WHEREAS, That certain Deed of Trust (the “**Deed of Trust**”), dated March 8, 2021, from Michelle Elaine Pence (“**Borrower**”), as Grantor to Teresa Lewellen, Trustee, filed for record on March 18, 2021 in Real Property Records of Jones County, Texas, more particularly described therein, which serves as security for a \$27,000.00 promissory note described therein (the “**Note**”) executed by Borrower, payable to the order of Centex Casas, LLC.

WHEREAS, the undersigned has been appointed Substitute Trustee in the place of the said original Trustee, upon the contingency and in the manner authorized by the Deed of Trust; and

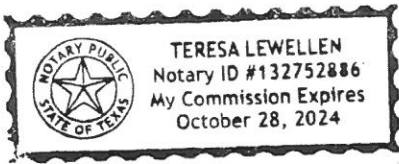
