

NOTICE OF TRUSTEE'S SALE and APPOINTMENT OF SUBSTITUTE TRUSTEE

THIS INSTRUMENT APPOINTS THE SUBSTITUTE TRUSTEE(S) IDENTIFIED TO SELL THE PROPERTY DESCRIBED IN THE SECURITY INSTRUMENT IDENTIFIED IN THIS NOTICE OF SALE. THE PERSON SIGNING THIS NOTICE IS THE ATTORNEY OR AUTHORIZED AGENT OF THE MORTGAGEE OR MORTGAGE SERVICER.

WHEREAS, on August 2, 2007, Jimmy D. Cudd and Cathy M. Cudd, husband and wife executed a Deed of Trust conveying to Mark Hargrove, Trustee, the real property hereinafter described, to secure Bobby L. Hall and Natalic Hall, husband and wife, in the payment of a debt therein described, said Deed of Trust being recorded in Volume 267, Page 447, Official Public Records of Jones County, Texas.

WHEREAS, default has occurred in the payment of said indebtedness, and the same is now wholly due, and the owner and holder of said debt has requested the hereinafter appointed Substitute Trustee to sell said property to the highest bidder for cash and to distribute or apply the proceeds of said sale in accordance with the terms of said Deed of Trust.

WHEREAS, in my capacity as the attorney for the present owner and holder of the note, and pursuant to Section 51.0076(3) Texas Property Code, I hereby name, appoint and designate <u>Terry Browder or Laura Browder or Marsha Monroc</u>, the Substitute Trustee(s) in the above described Deed of Trust and/or to act under and by virtue of said Deed of Trust, including posting and filing the public notice required under Section 51.002 Texas Property Code as amended, and to proceed with a foreclosure of the Deed of Trust lien securing the payment of said note.

NOW, THEREFORE, NOTICE IS HEREBY GIVEN that on Tuesday, February 7, 2017, at 1:00 o'clock p.m. or within three (3) hours thereafter, the Substitute Trustee will sell said real property at the place hereinafter set out, to the highest bidder for cash. The place of sale shall be in the area designated by the Commissioners Court of such County, pursuant to §51.002 of the Texas Property Code as the place where foreclosure sales are to take place (if such place is not so designated, the sale will take place in the area where this Notice of Substitute Trustee's Sale is posted), in the City of Anson, Jones County, Texas.

Said real property is described as follows:

BEING 2.390 acres out of a 4.726 acre tract, recorded in Volume 188, Page 672, Official Public Records, Jones County, Texas out of the G. Martinez Survey No. 195, Jones County, Texas. Said 2.390 acre tract being more particularly described in

Exhibit "A" attached hereto.

The Deed of Trust permits the Beneficiary to postpone, withdraw, or reschedule the sale for another day. In that case, the Trustee under the Deed of Trust or Substitute Trustee appointed herein need not appear at the date, time and place of a scheduled sale to announce the postponement, withdrawal, or rescheduling. Notice of the date of any rescheduled foreclosure sale will be reposted and refiled in accordance with the posting and filing requirements of the Texas Property Code. The reposting or refiling may be after the date originally scheduled for this sale.

Pursuant to Section 51.009 of the Texas Property Code, the property will be sold in "AS IS, WHERE IS" condition, without any express or implied warranties, except as to the warranties of title (if any) provided for under the Deed of Trust. Prospective bidders are advised to conduct an independent investigation of the nature and physical condition of the property and the priority of the lien being foreclosed.

The sale will be conducted as a public auction to the highest bidder for cash, subject to the provisions of the Deed of Trust permitting the Beneficiary thereunder to have the bid eredited to the Note up to the amount of the unpaid debt secured by the Deed of Trust at the time of sale.

Those desiring to purchase the property will need to demonstrate their ability to pay their bid immediately in cash if their bid is accepted.

The sale will be made expressly subject to any title matters set forth in the Deed of Trust, but prospective bidders are reminded that by law the sale will necessarily be made subject to all prior matters of record affecting the property, if any, to the extent that they remain in force and effect and have not been subordinated to the Deed of Trust. The sale shall not cover any part of the property that has been released of public record from the lien of the Deed of Trust. Prospective bidders are strongly urged to examine the applicable property records to determine the priority, nature and extent of such matters, if any.

In the event of a defect or other problem with the foreclosure process is discovered that may invalidate the sale, the consideration paid will be returned to the purchaser as the sole and absolute remedy. In the event of any claim or action brought by any person including the purchaser requiring or resulting in the invalidation of the sale and rescission of the Trustee's Deed or Substitute Trustee's Deed, purchaser's damages resulting therefrom are limited to the consideration paid to the Trustee or Substitute Trustee and the sole and absolute remedy shall be the return to purchaser of the consideration paid. The purchaser shall have no further recourse against the Trustee, Substitute Trustee, Mortgagor, Mortgagee or the Mortgagee's attorney.

EXHIBIT "A" LEGAL DESCRIPTION

BEING 2.390 acres out of a 4,725 acre tract, recorded in Volume 188, page 672, Official Public Records, Jones County, Texas, out of the G. Martinez Survey No. 195, Jones County, Texas. Said 2.390 acre tract being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod found on the east line of U.S. Highway 277, and the south line of Jones County Road 379, at the northwest comer of said 4.726 acre tract;

THENCE North 76 deg. 18 min. 00 sec. East, with the south line of said Jones County Road 379, and the north line of said 4.725 acre tract, 508.01 feet to a 3/8 inch iron rod found at the northwest corner of a 0.5 acre Cemetery tract;

THENCE South 14 deg. 59 min. 30 sec. East, with the west line of said Cemetery tract, passing the southwest corner of said Cemetery tract at a distance of 147.58 feet, and continuing a total distance of 204.60 feet to a 1/2 inch iron rod found i the south line of said 4.726 acre tract, same being in the north line of a 4.890 acre tract, recorded in Volume 188, Page 672, Official Public Records, Jones County, Texas;

THENCE South 75 deg. 00 min. 05 sec. West, along the common line of said 4.726 acre tract, and said 4.890 acre tract, a distance of 495.82 feet to a 1/2 inch iron rod found for the southwest corner of said 4.726 acre tract, same being the northwest corner of said 4.890 acre tract, same being in the east line of said U.S. Highway 277;

THENCE North 12 deg. 18 min. 53 sec. West, along the common line of said 4.726 acre tract, and the east line of said U.S. Highway 277, a distance of 129,12 feet to a 1/2 inch iron rod set for corner;

THENCE North 26 deg. 43 min. 22 sec. West, along the common line of said 4.726 acre tract, and the east line of said U.S. Highway 277, a distance of 88.99 feet to the point of beginning and containing 104,104 square feet or 2.39 acres of computed land.
