## JONES COUNTY COMMISSIONERS COURT REGULAR MEETING JULY 26, 2021 - 9:00 AM

The Commissioner's Court of Jones County, Texas, met this day in regular session with the following members present: Dale Spurgin, County Judge, presiding; Roy Spalding, Commissioner Precinct 1; Lonnie Vivian, Commissioner Precinct 2; Todd McWilliams, Commissioner Precinct 3; Joel Spraberry, Commissioner Precinct 4; and LeeAnn Jennings, Jones County Clerk.

- 1. APPROVE MINUTES OF LAST REGULAR MEETING. Commissioner Spraberry entered a motion to approve the minutes from the July 12, 2021 meeting as presented. Commissioner Vivian seconded the motion with all other Commissioners voting aye.
- 2. DISCUSS AND TAKE ACTION ON A BID SUBMITTED BY DARRELL HOPKINS AND WANDA HOPKINS FOR THE PURCHASE OF 22112, T&P 15 SURVEY #50 ABSTRACT 1837. THE BID AMOUNT IS \$2500.00. THE COURT COSTS ARE \$1187.00. Commissioner Vivian entered a motion to approve a bid in the amount of \$2500 submitted by Darrell Hopkins and Wanda Hopkins for the purchase of R22112. - 21. DISCUSS AND TAKE ACTON TO RATIFY BRYANT'S PLUMBING ESTIMATE FOR THE COUNTY JAIL. Commissioner Spraberry entered a motion to ratify Bryant Plumbing's estimate to replace the mixing valve and replace the recirculating pump in the mechanical room at the Jones County Jail. Commissioner McWilliams seconded the motion with all other Commissioners voting aye. See Exhibit H.

DISCUSS AND TAKE ACTION TO RATIFY LAN COMMUNICATIONS FOR CAR RADIO SYSTEMS.** Commissioner Vivian entered a motion to approve LAN Communication's bid in the amount of \$13,678.70 to repair car radio systems for the Jones County Sheriff's Department.
