REGULAR MEETING
JUNE 28, 2021 - 9:00 AM**


The Commissioner's Court of Jones County, Texas, met this day in regular session with the following members present: Dale Spurgin, County Judge, presiding; Lonnie Vivian, Commissioner Precinct 2; Todd McWilliams, Commissioner Precinct 3; Joel Spraberry, Commissioner Precinct 4; and LeeAnn Jennings, Jones County Clerk.

- 1. APPROVE MINUTES OF LAST REGULAR MEETING.**
Commissioner Spraberry entered a motion to approve the minutes of the June 14, 2021 regular meeting as presented. Commissioner Vivian seconded the motion with Commissioner McWilliams and Judge Spurgin voting aye.
- 2. DISCUSS AND TAKE ACTION 2020 AUDIT PRESENTATION BY JAMES E RODGERS AND COMPANY PC.** Commissioner Vivian entered a motion to accept the 2020 audit from James E Rogers and Company PC. Commissioner McWilliams seconded the motion with Commissioner Spraberry and Judge Spurgin voting aye. See Exhibit A.






 County Judge




 Commissioner Precinct 2




 Commissioner Precinct 4
