

**JONES COUNTY COMMISSIONERS COURT
REGULAR MEETING
MAY 26, 2020 - 9:00 AM**

The Commissioner's Court of Jones County, Texas, met this day in regular session with the following members present: Dale Spurgin, County Judge, presiding; James Clawson, Commissioner Precinct 1; Lonnie Vivian, Commissioner Precinct 2; Ross Davis, Commissioner Precinct 3; Joel Spraberry, Commissioner Precinct 4; and LeeAnn Jennings, County Clerk.

1. **APPROVE MINUTES OF LAST REGULAR MEETING.** Commissioner Vivian entered a motion to approve the minutes from the May 11, 2020 regular meeting as presented. Commissioner Davis seconded the motion with all other Commissioners voting aye.

21. PAY BILLS.


Commissioner Davis entered a motion to pay the bills as presented by the County Auditor. Commissioner Vivian seconded the motion with all other Commissioners voting aye.

22. DISCUSS AND TAKE ACTION ON 2021 BUDGET WORKSHOP.


No action was taken by the Commissioners Court.

County Judge



Commissioner Precinct 2
