

NOTICE OF NON-JUDICIAL FORECLOSURE SALE

WHEREAS, on June 8, 2023, David Lee Ashley, Jr. and Cameron Michell Green as Grantors to Linda Booker, Trustee, executed a Deed of Trust to secure in the payment of that certain Promissory Note of even date therewith in the principal sum of **\$43,500.00 (Forty Three Thousand, Five Hundred Dollars) payable to Mint, Inc** said Deed of Trust being filed for record on June 20, 2023 as document #231810 of the Jones County Clerks Records and further assigned by Assignment of Mortgage Deed to Secure Debt on June 28, 2023 to Casa Roble 1, LLC Assignee, recorded as document # 232001 of the Jones County Clerk Records.
