

NOTICE OF NON-JUDICIAL FORECLOSURE SALE

WHEREAS, That certain Deed of Trust (the "Deed of Trust"), dated October 30, 2015 from Roger Turner and Glenda Havens ("Borrower"), as Grantor to Ryan Coggin, Trustee, filed for record in Real Property Records of Jones County, Texas on November 6th, 2015 as Instrument Number 152580, in Volume 417, Pages 727-730, more particularly described therein, which serves as security for a \$28,900.00 promissory note described therein (the "Note") executed by Borrower and payable to the order of HB EQUITY, LLC and subsequently assigned to Homestead Opportunity Fund, LP on November 17, 2015 by Assignment of Mortgage, filed for record in Real Property Records of Jones County, Texas on November 30th, 2015 as Instrument Number 152762 in Volume 418, Pages 672 & 673.
