

NOTICE ABOUT 2020 TAX RATES

Property Tax Rates in Jones County

This notice concerns the 2020 property tax rates for Jones County. This notice provides information about two tax rates used in adopting the current tax year's tax rate. The no-new-revenue tax rate would impose the same amount of taxes as last year if you compare properties taxed in both years. In most cases, the voter-approval tax rate is the highest tax rate a taxing unit can adopt without holding an election. In each case, these rates are calculated by dividing the total amount of taxes by the current taxable value with adjustments as required by state law. The rates are given per \$100 of property value.

This year's no-new-revenue tax rate:	\$0.625985
This year's total voter-approval tax rate:	\$0.654231

Indigent Health Care Compensation Expenditures

The Jones County spent \$128,135 from July 1 2019 to June 30, 2020. This increased the voter-approval tax rate by \$.007487/\$100.

Indigent Defense Compensation Expenditures

The Jones County spent \$ 222,556 from July 1, 2019 to June 30, 2020 to provide appointed counsel for indigent individuals, less the amount of state grants received by the county. In the preceding year, the county spent \$175,600 for indigent defense compensation expenditures. The amount of increase above last year's indigent defense expenditures is \$0. This increased the voter-approval rate by \$.001175 /\$100 to recoup the increased expenditures.
