

ORDER AND DECLARATION OF THE JONES COUNTY COMMISSIONERS COURT EXTENDING THE COUNTY'S DISASTER DECLARATION AND ORDER OF DECEMBER 27, 2022, AS AMENDED BY THE COMMISSIONERS COURT HEREIN, AND DECLARING A STATE OF DISASTER AND PUBLIC HEALTH EMERGENCY FOR JONES COUNTY, TEXAS, SUCH BEING AMENDMENT #35.

WHEREAS, in December 2019, a novel coronavirus, now designated COVID-19, was detected in Wuhan, China; and

WHEREAS, on January 30, 2020, the World Health Organization Director General declared the outbreak of COVID-19, as a *Public Health Emergency of International Concern*, advising countries to prepare for the containment, detection, isolation and case management, contact tracing and prevention of onward spread of the disease; and

WHEREAS, on March 5, 2020, the World Health Organization Director General urged aggressive preparedness and activation of emergency plans to aggressively change the trajectory of this epidemic; and

WHEREAS, the Center for Disease Control and Prevention ("CDC") is closely monitoring the growing number of COVID-19 cases that have spread into the United States; and

WHEREAS, on March 13, 2020, Texas Governor Greg Abbot announced COVID-19 as a public disaster and declared a statewide emergency in the State of Texas; and

WHEREAS, since March 13, 2020, Governor of the State of Texas ("Governor") has issued multiple Executive Orders pertaining to COVID-19; and

WHEREAS, on March 19, 2020, the Commissioner for the Texas Department of State Health Services has declared a public health disaster for the entire state of Texas,

WHEREAS, on March 30, 2020, the Commissioners Court for Jones County declared A STATE OF DISASTER AND PUBLIC HEALTH EMERGENCY FOR JONES COUNTY, TEXAS;

WHEREAS, the COVID-19 virus spreads between people who are in close contact with one another through respiratory droplets produced when an infected person coughs or sneezes; and

WHEREAS, the continued worldwide spread of COVID-19 presents an imminent threat of widespread illness, which requires emergency action; and

WHEREAS, a declaration of local disaster includes the ability to take measures to reduce the possibility of exposure to disease, control the risk and promote the health and safety of individuals in JONES County, Texas; and

WHEREAS, the County Judge of JONES County has determined, from statements and information provided by the Office of the Texas Governor, JONES County Emergency Management, Texas Department of State Health Services, the Health Authority of Jones County, and other health agencies serving the State of Texas that extraordinary measures must be taken in order to limit the development, contraction and spread of COVID-19 in JONES County, Texas; and

WHEREAS, based on the Governor's request and the fact that there are now reported cases of individuals testing positive for COVID-19 in JONES County, there is the need to take further action.

NOW, THEREFORE, BE IT ORDERED BY THE COMMISSIONERS COURT OF JONES COUNTY, TEXAS UNDER THE AUTHORITY OF TEXAS GOVERNMENT CODE SECTION 418.108:

1. That the local state of disaster and public health emergency declared for JONES County, Texas, is hereby EXTENDED, and that the County's Order is ADOPTED AND RESTATED except as AMENDED herein by this Court based on new developments. A local state of disaster and public health emergency in JONES County is DECLARED.
2. Pursuant to §418.108(c) of the Texas Government Code, this declaration of a local state of disaster shall be given prompt and general publicity and shall be filed promptly with the County Clerk.
3. Pursuant to §418.108(d) of the Texas Government Code, this declaration of a local state of disaster activates the County's emergency management plan.
4. Although this Order amends a prior order and releases restrictions the Commissioners Court has set in the past, the restrictions set out in the Executive Orders issued by the Governor continue and all residents of Jones County, and the state of Texas, shall abide by such restrictions or be subject to the penalties set out herein.
5. IT IS ORDERED THAT persons coming to the Jones County Courthouse is discouraged. however, the Courthouse is open to the public. Each elected official may establish any restrictions as to access to its specific offices. These shall restrictions shall be posted by the respective elected official and on the County website.
6. Jones County orders that due to social distancing requirements, Jones County names the Senior Citizens Activity Center, located at 1102 West Court Plaza in Anson, Texas as an Annex to be used as a district courtroom for the 259th Judicial District Court. Attendees of any proceedings in any 259th Judicial District Court courtroom shall adhere to all district court rules, which include the wearing of face masks and social distancing of 6 feet, among other requirements.
7. Jones County grants an addition 80 hours of sick leave if such sick leave is related to the COVID-19 virus AND if 1) a health care provider states the employee is to remain away from his or her work for a period of time of up to 10 working days OR 2) that employee's elected official approves such leave and the elected official believes that such sick leave is

related to COVID-19 virus. Such sick leave must be otherwise consistent with current employee policy manual guidelines.

Jones County grants an additional 80 hours of sick leave if such sick leave is related to the COVID-19 virus to replace the Families First Coronavirus Response Act that expired on December 31, 2020.

Jones County grants an additional 80 hours of sick leave if such sick leave is related to the COVID-19 virus.


Therefore; Jones County grants up to 240 total hours of sick leave if such sick leave is related to the COVID-19 virus. Jones County also extends the requirement for HB 2073 related to first responders quarantine leave to all full-time employees.

Jones County grants part time employees up to 3 payroll periods of sick leave if such sick leave is related to the COVID-19 virus. Part time employees' schedule are determined to be consistent with the previous 2 payroll periods. The Commissioners Court will require approval for any other option of a part time employees schedule. Part time employees are not eligible for regular sick leave or sick pool leave.

Jones County grants the opportunity for an application to the sick pool when an employee has been hospitalized for a COVID-19 related illness

8. The Courthouse will NOT be open as a shelter in the event of a severe weather event.
9. Individuals entering into the Courthouse or any county owned building are encouraged to wear face coverings, maintain social distancing of 6 feet, and wash hands and use hand sanitizers, among other CDC requirements or Texas State Health Services guidelines.
10. To the extent that these restrictions are in conflict with any Executive Order issued by the Governor but only to the extent that such conflict restricts essential services allowed by an Executive Order or this order allows gatherings prohibited by an Executive Order, that provision of such Executive Order governs and supersedes the restriction set out herein. The remainder of this Declaration for Jones County shall remain in effect.
11. **This ORDER shall become effective at 12:01 a.m. Wednesday, December 28, 2022, and shall end on January 23, 2023, at 11:59 p.m.**
12. The County will promptly provide copies of this Order by posting it on the County's website. In addition, the owner, manager, or operator of any facility that is likely to be impacted by this Order is strongly encouraged to post a copy of this Order onsite and to provide a copy to any member of the public asking for a copy.
13. If any subsection, sentence, clause, phrase, or word of this Order or any application of it to any person, structure, gathering, or circumstance is held to be invalid or unconstitutional by a decision of a court of competent jurisdiction, then such decision will not affect the validity of the remaining portions or applications of this Order.
