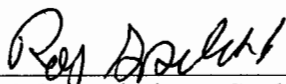


AFFIDAVIT

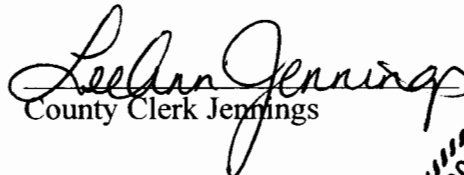
