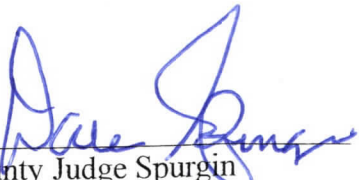
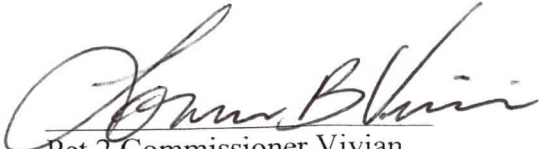


AFFIDAVIT
