

**JONES COUNTY COMMISSIONERS COURT  
REGULAR MEETING  
APRIL 26, 2021 - 9:00 AM**

The Commissioner's Court of Jones County, Texas, met this day in regular session with the following members present: Dale Spurgin, County Judge, presiding; Roy Spalding, Commissioner Precinct 1; Lonnie Vivian, Commissioner Precinct 2; Todd McWilliams, Commissioner Precinct 3; Joel Spraberry, Commissioner Precinct 4; and LeeAnn Jennings, Jones County Clerk.

1. **APPROVE MINUTES OF LAST REGULAR MEETING.** Commissioner Vivian entered a motion to approve the minutes from the April 12, 2021 regular meeting as presented. Commissioner Spalding seconded the motion with all other Commissioners voting aye.
2. **DISCUSS AND TAKE ACTION ON A BID SUBMITTED BY CITY OF STAMFORD FOR THE PURCHASE OF (R27364) LOT 11, IN BLOCK 59, OF THE ORIGINAL TOWN OF STAMFORD, JONES COUNTY, TEXAS. THE BID AMOUNT IS \$10.00. COURT COST HAS BEEN WAIVED.** Commissioner Vivian entered a motion to approve a bid in the amount of \$10 submitted by the City of Stamford for the purchase of R27364. **21. PAY BILLS.**




**22. DISCUSS AND TAKE ACTION ON 2022 BUDGET WORKSHOP.**

Commissioner Vivian entered a motion to adjourn. Commissioner McWilliam seconded the motion with all other Commissioners voting aye.


