

**JONES COUNTY COMMISSIONERS COURT  
REGULAR MEETING  
JUNE 24, 2024 - 9:00 AM**

The Commissioner's Court of Jones County, Texas, met this day in regular session with the following members present: Roy Spalding, Commissioner Precinct 1; Lonnie Vivian, Commissioner Precinct 2, presiding; Ross Davis, Commissioner Precinct 3; Joel Spraberry, Commissioner Precinct 4; and LeeAnn Jennings, Jones County Clerk. Dale Spurgin, County Judge was absent.

**1. APPROVE MINUTES OF THE LAST REGULAR MEETING.**

Commissioner Spalding entered a motion to approve the minutes from the June 10, 2024 regular meeting as presented. Commissioner Davis seconded the motion with all other Commissioners voting aye.

Commissioner Spraberry entered a motion to adjourn. Commissioner Davis seconded the motion with all other Commissioners voting aye.


