

**JONES COUNTY COMMISSIONERS COURT
REGULAR MEETING
JULY 28, 2025 - 9:00 AM**

The Commissioner's Court of Jones County, Texas, met this day in regular session with the following members present: Dale Spurgin, County Judge, presiding; Roy Spalding, Commissioner Precinct 1; Lonnie Vivian, Commissioner Precinct 2; Danny Collett, Commissioner Precinct 3; Joel Spraberry, Commissioner Precinct 4; and LeeAnn Jennings, Jones County Clerk.

1. APPROVE MINUTES OF THE LAST REGULAR MEETING.

Commissioner Spalding entered a motion to approve the minutes from the July 14, 2025 regular meeting as presented. Commissioner Vivian seconded the motion with all other Commissioners voting aye.

2. DISCUSS AND TAKE ACTION ON APPROVING ALL TRUST PROPERTY BIDS AS ONE ACTION ITEM, AGENDA ITEMS 3-4. Commissioner Vivian entered a motion to approve agenda items three and four in one action. Commissioner Spalding seconded the motion with all other Commissioners voting aye.


31. DISCUSS AND TAKE ACTION ON TREASURER'S REPORT.


32. AMEND BUDGET AND APPROVE LINE-ITEM TRANSFERS.


33. PAY BILLS.


Commissioner Vivian entered a motion to adjourn. Commissioner Spalding seconded the motion with all other Commissioners voting aye.



County Judge
