

**JONES COUNTY COMMISSIONERS COURT
CALLED MEETING
FEBRUARY 2, 2026 - 9:00 AM**

The Commissioner's Court of Jones County, Texas, met this day in regular session with the following members present: Dale Spurgin, County Judge, presiding; Roy Spalding, Commissioner Precinct 1; Lonnie Vivian, Commissioner Precinct 2; Danny Collett, Commissioner Precinct 3; Joel Spraberry, Commissioner Precinct 4; and LeeAnn Jennings, Jones County Clerk.

1. APPROVE MINUTES OF THE LAST REGULAR MEETING.

Commissioner Spalding entered a motion to approve the minutes of the January 12, 2026 regular meeting as presented. Commissioner Vivian seconded the motion with all other Commissioners voting aye.

Commissioner Spalding entered a motion to approve the purchase of video storage from CML Security in the amount of \$22,227.00 with \$10,00.00 paid from commissary and \$12,227.00 paid from permanent improvement as well as the purchase of a CCTV station purchased from CML Security in the amount of \$6,740.00 paid from commissary. Commissioner Vivian seconded the motion with all other Commissioners voting aye. See Exhibit M.

24. DISCUSS AND TAKE ACTION ON DATAPILOT GRANT FOR SHERIFF'S DEPARTMENT.

Commissioner Vivian entered a motion to approve the DATAPILOT for the Sheriff's department for forensic software in the amount of \$4,495. The grant amount is \$3,495 with the county paying \$1,000 from the investigation fund. Commissioner Spalding seconded the motion with all other Commissioners voting aye. See Exhibit N.

28. AMEND BUDGET AND APPROVE LINE-ITEM TRANSFERS.


No action was taken by the Commissioners Court.

Commissioner Vivian entered a motion to pay the bills as presented by the Auditor. Commissioner Spalding seconded the motion with all other Commissioners voting aye.







County Judge
