


1. **PURSUANT TO CHAPTER 552 OF THE TEXAS GOVERNMENT CODE, THE PUBLIC IS HEREBY GIVEN NOTICE THAT THE COMMISSIONERS COURT OF (JONES) COUNTY, TEXAS WILL CONVENE IN SPECIAL SESSION ON THE 12 DAY OF NOVEMBER 2021, AT 9:00 A.M. TO RECEIVE PUBLIC COMMENT ON REDISTRICTING OF COUNTY ELECTION, JUSTICE OF THE PEACE AND COMMISSIONERS COURT PRECINCTS. AFTER THE PUBLIC HEARING, THE COMMISSIONERS COURT WILL TAKE UP FOR CONSIDERATION AND TO TAKE POSSIBLE ACTION REGARDING ONE OR MORE ALTERNATIVE PLANS FOR THE REDISTRICTING OF COUNTY COMMISSIONERS COURT PRECINCTS. THE COURT RESERVES THE RIGHT TO TAKE ANY AND ALL APPROPRIATE ACTIONS REGARDING THE REDISTRICTING OF (COUNTY NAME) COUNTY POLITICAL BOUNDARIES, INCLUDING THE ACCEPTANCE OF NEW BOUNDARIES FOR THE COMMISSIONERS COURT PRECINCTS, MODIFICATION OF ANY BOUNDARIES, AND/OR TABLING THE PENDING PROPOSALS FOR LATER CONSIDERATION AND/OR ACTION.** After no comment was made from the public,




**ADJOURN**


Commissioner Spraberry entered a motion to adjourn. Commissioner Spalding seconded the motion with all other Commissioners voting aye.


